- 5) For all Theory & Practical Examinations, the Pattern of Question Paper should be same such as University Examinations.
- 6) The Concerned Head of Department and Principal will be responsible to conduct all internal examinations.
- 7) For all term end examinations, written timetable should be displayed on Notice Board, minimum seven days before the commencement of Examinations.
- 8) All Examinations (Term end & Practical) must be conducted and planned before the last date of submission of Internal Assessment marks notified by the University as per provisions of Ordinance No. 1/2002 (amended).



SUBMISSION OF INTERNAL ASSESSMENT MARKS
FOR WINTER - 2021 EXAMINATIONS

It is notified to all concerned that as per Section 47 prescribed in the University Ordinance No.01/2014, affiliated Colleges have to conduct Internal Assessment Examinations.

- Software for submission of Internal Assessment marks for Undergraduate Courses (All Faculties 1st to Final year and University Courses) will be made available on University website around **18th February 2022**.
- The University has already provided College Log-in account to every college, from where hall tickets of their students are downloaded by them. For entry of Internal Assessment marks in the software, the Colleges are required to Log-in their respective account and carry out entry of Internal Assessment marks.
- Internal Assessment mark list (Hard Copy & Soft copy) is to be submitted to the University on or before **23rd February 2022**. No further extension will be granted by the University.
- Internal Assessment Examination of **Repeater student** shall be conducted in respective subject only. The Colleges are required to maintain Internal Assessment record of Repeater students as per attached format and compulsory submitted to the University with online marksheet format.
- While preparing Final Marks of Internal Assessment, the rounding-off marks shall done as illustrated in following table as per BOE Resolution No.07/2007 dated 08.01.2007.


Example:

Internal Assessment Marks	Final Rounded Marks
15.01 To 15.49	15
15.50 To 15.99	16

- It is repeatedly observed that certain colleges have approached to the University for change in Internal Assessment marks after initial submission OR even after declaration of Final result on various frivolous grounds. **No request for 'change of marks' shall be considered, once marks are submitted by the College to the University. It is therefore decided that Internal Assessment marks lists will only be accepted in case it is signed by the student with counter signature of the HOD/Dean of the college as provided in Ordinance 1/2014.** Liability of any clerical error at college-level will rest with the Dean and the concerned HOD. The Colleges are therefore requested to go into all details and thereafter Final Internal Assessment marks lists shall be submitted to the University.

- The Colleges, who fails to submit Internal Assessment marks (Hard copy and Soft copy) upto stipulated time-period, will be imposed fine/ penalty as prescribed by the University under Notification No.09/2011 dated 11.03.2011.
- Non-submission of Internal Assessment marks shall constrain the University to withheld hall-ticket of the students. Hall tickets of the students, whose marks are submitted without signature, will also be withheld by the University and any loss to the students shall rest with the concerned College.

The Dean/Principal of the Colleges are required to bring this circular to the notice of all concerned & ensure that Internal Assessment marks as prescribed and is submitted to the University within stipulated time-period.

Applicability of ATKT facility and Number of Attempts including Maximum 9 Years Time-Limit for Passing of Bachelor of Ayurvedic Medicine & Surgery (BAMS) / Bachelor of Unani Medicine & Surgery (BUMS) course to be applicable w.e.f. Academic Year 2017-2018 & onwards

Ref.: Academic Council Resolution No. 204/2017 dated 26/09/2017

It is notified to all concerned that pursuant to applicability of ATKT facility and Number of Attempts including Maximum 9 years time-limit, prescribed by the Central Council of Indian Medicine vide its regulations dated 7th November 2016, for passing of all BAMS & BUMS course examinations so as to become eligible for joining Internship Training Programme was placed before the Academic Council for its consideration in its meeting held on 26/09/2017. After deliberations, it has resolved to adopt criteria prescribed by the CCIM to the candidates admitted w.e.f. Academic Year 2017-2018 & onwards as follows:

Bachelor of Ayurvedic Medicine & Surgery (BAMS) and Bachelor of Unani Medicine & Surgery (B.U.M.S.)	
First Year	The failed student of <u>first professional</u> shall be allowed to appear in <u>second professional examination</u> , but the student shall not be allowed to appear in <u>third professional examination</u> unless the student passes all the <u>subjects of first professional examination</u> and <u>maximum four chances</u> shall be given to pass <u>first professional examination</u> within a period of maximum three years.
Second Year	The failed student of <u>second professional</u> who have passed all the subjects of <u>first professional examination</u> shall be allowed to appear in <u>third professional examination</u> , but the student shall not be allowed to appear in <u>final professional examination</u> unless the student passes all the <u>subjects of second professional examination</u> and <u>maximum four chances</u> shall be given to pass <u>second professional examination</u> within a period of maximum three years.
Third Year	The failed student of <u>third professional</u> who have passed all the <u>subjects of first & second professional examinations</u> shall be allowed to appear in <u>final professional examination</u> and <u>maximum four chances</u> shall be given to pass <u>third professional examination</u> within a period of <u>maximum three years</u> .
Final Year	The student failed in any of the four professional examinations in four chances shall <u>not be allowed to continue his or her studies</u> .

It is clarified that after passing all subjects from First Year to Final Year University Examination, Internship Training Programme shall be commenced by the respective College. On completion of requisite number of attempts, the College is required to discharge the respective candidate from the course as well as shall ensure that examination forms of such candidates shall not be submitted to the University. In case, if any College fails to observe above guidelines and if any legal matter arises out of it, the concerned College shall be held responsible. Penal action will be initiated, as decided by the Board of Examinations, against the defaulter college/(s) towards any such lapses.

The Dean/Principal of the College is required to take an undertaking from the enrolled candidate as per attached *Annexure 'A'* within One month time-period of admission granted to the candidate in the College every year and maintain a copy of this undertaking in candidate's personal file to be maintained at the College-level. The Dean/Principal of the College is also required to give wide publicity to this notification at their college-level and must ensure that it is brought to the notice of admitted students every year, so as to avoid any legal complications at a later stage.

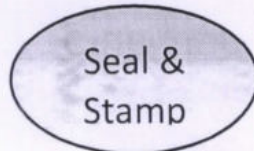

In connection to above referred circular/notification, all H.O.D. of the Colleges are, therefore, requested to Submit Internal Assessment Marks between 21/04/2017 to 30/04/2017 positively.

- 1) It is the combined responsibility of the H.O.D. & Dean/Principal to submit online Internal Assessment Examination marks online to the University. Please follow above mentioned circulars/notification for more information..
- 2) After submission of online marks, the College shall take printout copy of Final Maarksheet & it shall be **duly signed & cross checked** by H.O.D. The marks entered on printed marksheet shall be the same which shall be entered in software also & then submit printed one copy **duly sealed to the University** within stipulated time period and keep second sealed copy of the printed marklist at College.
- 3) The College Coordinator in consultation with the Dean/Principal shall make all arrangement of submission of online marks submission to the University. The Dean/Principal of the college is requested to inform the respective H.O.D. regarding this circular.
- 4) It is the responsibility of the Dean/Principal/H.O.D. to follow the existing Rules/Regulations/Direction/Circulars. The University has prescribed following guidelines; the Dean/Principal/H.O.D. are requested to go through it and requested to act as per guidelines mentioned overleaf:-

Guidelines/Steps for Online Submission of Marks

- 1) Log-on to website www.practical.muhs.edu.in by using the Username and Password already provided for downloading Hall tickets. If any College has not yet received Username or password or forgot Username/Password, then click on 'Forgot Username and Password' and follow steps specified and the system will send you username and password by SMS and Email.
- 2) After login, **OTP** will be sent on your registered **Email ID** of the college. After receipt of OTP, enter OTP and click "verify OTP".
- 3) After successfully entry of OTP, go to menu '**Internal Assessment->Internal Assessment Marks Submission**'.
- 4) On the online marks entry screen,
 - a) Select Subject by clicking '**Select**'
 - b) **Select Seat Number, Student Name**
 - c) Click '**Show Marklist**' after which marklist will be displayed.
 - d) Enter Marks in '**Obtained**' column and press '**Enter**' key '**or**' Click '**Save**' button.
 - e) To amend marks in specific sub-head, click on respective sub-head's '**Edit**' button.
- 5) During data entry of marks, the H.O.D. can preview marklist by clicking "**Preview Marklist**" and after again clicking on "**| Click here to Open Marklist |**", it will open marklist in new tab/window for review. Verify the marklist as per instruction mentioned below in (a) to (e).
- 6) After cross-checking of previewed marklist, the H.O.D. shall submit the marklist by clicking 'Submit Marklist'. The screen will prompt as '*We have VERIFIED MARKS ENTERED and we have certified that the marks entered against each Seat Number are found correct*'. Click '**Accept and Continue**' button for final submission of marklist. Please note that, once you have submitted the marks, it cannot be updated. If any correction required at this stage, click '**Cancel**' button for make corrections. If all mark... entered are found to be correct, then only click '**Accept and Continue**'.
- 7) After 'Accept and Continue', **take two print-out of Final Marklist** by clicking 'Print Final Marklist' & verify the marklist as per instruction mentioned below in (a) to (e). The H.O.D. are also required to check overall format, wording and spelling of printed marklist.
 - a) **Part I** - Check Name of Examination (Summer-2016, etc.).
 - b) **Part II** - Check whether Subject Name, Course Name, Centre Name, Min.Max.Marks, etc. are correctly reflected or not as per data entry.
 - c) **Part III** - Check Sub-head names from approved format of Internal Assessment Marklist.
 - d) **Part IV** - Whether all marks are correctly reflected in marklist as entered by you.
